REACH – Eurojersey S.p.A. REACH Declaration

To our Customers:

REACH is the acronym for: Registration, Evaluation, Authorisation and Restriction of Chemicals.

EEC/EU REACH Regulation n. 1907/2006, dated 18/12/2006 and published in the Official European Union Gazette in issue n. L396 of 30/12/2006 (concerning the registration, evaluation, authorisation and restriction of chemicals), went into effect on 1 June 2007 and was acknowledged by Italian Law by Decree n.145 dated 28 July 2008.

The REACH regulation concerns all aspects relative to the dangerous nature of chemical substances that are circulating within the European market and regards all parties involved in the chemical substances sector (from producers and importers to final “downstream users”).

Furthermore, to address that which is foreseen in EEC/EU REACH regulation n. 1907/2006 dated 18/12/2006 and published in the European Union Gazette, issue number L396 of 30/12/2006 and with particular regard to Article 7 “**Registration and Notification of Substances Contained in Articles**” we would like to point out the following:

The chemical substances contained in the articles produced by Eurojersey S.p.A. are not intended to be released under normal or reasonably foreseeable conditions of use and therefore no registration on the part of Eurojersey S.p.A. (with the chemical substance Agency) is necessary for the substances contained in the articles that the company produces.

Furthermore, we exclude the presence of the following substances in such concentrations that would render it necessary to notify the Agency:

- Class 1 or 2 CMR (Carcinogenic, Mutagenic or Toxic to Reproduction);
- PBT (Persistent Bio-accumulative Toxic) and vPvB (very Persistent and very Bio-accumulative);
- Endocrine disrupting properties or properties that have been scientifically proven to have probable serious effects on human health or on the environment (identified on the basis of a case-by-case evaluation) which would cause concern equivalent to that that caused by other substances that are subject to said notification procedure.
